- Recreation Updates by Mikki
 - o Pump House Update –

Mikki spoke with the Electrician who will replace the heaters this week. Mikki will need a check for \$250 to include heaters and labor.

o Pool / Pool House Updates –

Clearwater will be out in early spring to repair the corner of the pool liner..

The water is turned off and drained.

- Waterfront Updates by Fred
 - o NH Dam Bureau Inspection –

Fred has not received the dam inspection report which was due on 10/29.

o Hidden Pond Dam/Spillway Update –

Fred received correspondence from H.L. Turner on 11/15 and will review. Turner proposes to present the cost for repairs in two phases; phase 1 to include engineering, studies, permits, and phase 2 for construction.

Fred forwarded to the Board a note recommendation for signage at the Hidden Lake prohibiting motorized craft.

Mikki: can we include a sign with trail usage restrictions for certain motorized vehicles at the pond and other public spaces?

Re: FEMA grant opportunity, Fred: our project may not meet the intent of the FEMA guidelines.

Mike: worth pursuing as we have made contact with the State Coordination Officer in the NH Div.

Chris to write up a summation of project scope to date for forwarding.

- Road Updates
 - Road Updates –

Chris is working with Donna Moxley on transition. Chris will touch base with Rusty this week. Chris to consider how we will divvy up responsibility. In good shape for upcoming snow season. Brush cutting can be pushed back to spring, potential savings of \$3,700 at this time.

Mikki: should Joe Traniello be in touch with Rusty? Chris: we can look at that, a second set of eyes is Good. Joe is willing to help until the Roads Director position is filled.

o Road Sign Updates (Trevor) –

Nothing new to report.

• Policy + Bylaw Committee

Chris: next Policy Committee meeting is next Monday. There are three policies on tonight's agenda.

Dangerous Activity & Noise Policy Easement & Setback Policy Animal Policy

Chris: these policies were drafted in 2014 but did not move forward. Mikki: HLA president at that time was not on board with moving the policies forward.

Re: **Dangerous Activity & Noise Policy**: Mikki: Noise Policy should be consistent with town ordinance which is 11:00 p.m. on holidays (fireworks). In regard to dogs; the communication sequence should be to the dog officer first, the sheriff second, and the state police third.

Chris: motion to accept Mikki's proposals, Mike/Fred: seconded. Approved. Chris to forward for e-signatures.

Re: Easement & Setback Policy: Chris: goal is to be clear. "Pin placement was inconsistent." New wording is 20' from center of road; that is, 10' from center of road + 10'. This is because road width varies. This definition provides clarity. An amendment is recommended to defer to an arbitrator if there is disagreement between property owner and HLA Board.

Chris: motion to approve with amendment, Mike seconded. Approved.

Re: Animal Policy

Chris: we need to be very clear on what is defined as a pet. Policy term and condition #2 reinforced in HLA the town policies. We can add that the sheriff be the first point of contact in the event of an incident who then can dispatch animal control.

Mikki: should dogs be fenced as they must be restrained? Fern: what about invisible fences?

Joe: what does the town leash law say? Mikki: we need to get a copy of the town leash law from Margo and attach to this policy. Chris: we can add the wording "secured" to cover invisible fences.

Mike: should a property owner have to post a sign if making use of an invisible fence?

Mikki: let's see what the town leash law says, is such a sign in the town ordinance? Mikki: we can adopt the towns rules? Should we have restrictions on bringing dogs to waterfront, public spaces? Does the town have pet restrictions that already cover this?

Chris: if the town has a leash law policy, we can add to this policy.

Chris: we will get a copy of the town policy from Michelle and then continue this discussion.
