#### HIDDEN LAKE ASSOCIATION BOARD MEETING

## 1. Address needs and concerns of guests, if applicable.

#### **Cris Carter:**

Chris gave a very thorough, informative presentation about the state of our plowing, grading, gravel needs, and culverts.

Re: **plowing**: Scenic and Nichols could have been plowed further off of road(s). Current contractor's tooling is really "only for fresh snow". Chris has appropriate equipment.

Re: **culverts**: three culverts need work, the priorities are Tigola Trail and Fox Hill. Rice Brook/No. Hidden Lake to follow. Chris has two tanks, 4' wide x 40' long and 1/2" wall thickness. Very suitable and installation ready, inner walls have been cleansed (evacuated, dried) by Suburban Propane. Chris will apply exterior coating.

To install these tanks would cost \$5K-\$5.5K. Chris strongly advises that we contact **DES** for approvals before beginning repair. DES would want to know about those culverts moving one body of water to another. He estimates that **DES** would approve of this install because of the urgency.

Chris is able to start the repairs immediately.

There are also, several 18" and 15" culverts (30'-40' in length) that are rusted out and in need of replacement, as well as many driveway culverts that are plugged or failed. The culverts can be repaired for \$2,500 each plus gravel. The driveway culverts can be repaired for \$1,800 each based on doing five (5) at a time if individual owners are interested.

Re: **grading:** Chris can start spring grading at month's end. Nichols is in immediate need but not as bad off as originally thought. Tree removal to allow sun access will expedite the drying out and result in less damage. Chris has a contact who does tree trimming and will find out what that contractor's day rate is. We spoke about how to spend \$10K for immediate grading/road work. Approx. seven loads of gravel is needed (which will do 500'-600'). Should budget \$10K for gravel and \$,3500 for performing the work. Henniker Store should be considered for better pricing and better grade of gravel.

Chris suggested that immediate needs for gravel are sections of Nichols, Tigola (up the hill from Woodlot to North Hidden), and lower Beaver Brook Drive.

Chris asked that we put aside \$7K -\$7.5K for ditching.

Grading is a five-day process. Graveling is a two-day process.

Chris asked that he be paid within 2-3 days of performing work.

## 2. Review and Acceptance of board minutes from March 21.

Chris and Mikki made additions. Motion by Chris, Fern seconded. Approved.
